Approve 1 Contract: Eastman & Smith, Ltd. in an amount not to exceed \$25,000 to provide legal services to Marion Public Health. The County Prosecutor's Office and County Commissioners have signed off approving this contract. The Common Pleas Court Judge will need to sign off and we expect that to happen tomorrow. Joseph Durham has extensive experience in local government law including public health law. The board discussed the legal notification terminating the agreement between the City of Marion and the District Advisory Council that was delivered on November 26th by Mayor Schertzer.

Andrew Carter, Marion Star, asked for some clarification on how the merger agreement was developed and how the health department has operated as a combined district since 2010. The current funding is based on a population split of 53/47 by City/County.


